A scandal brewing at Kasarani CDF

THERE is uncertainty on the where about of KSH 471 500 that was withdrawn on July 18<sup>th</sup> 2007 by the Kasarani CDF sub committee for the Mathare North road project by Mr. William Omondi Agara in the company of Mr. Phillip Odero Ochacha and one Vitalis Otullo, from the Co-operative bank account number 0112088731900. Our sources have confirmed that the money was given to Mr. William Agara and has not been handed over to the project committee.

Prior to the above withdrawal, another withdrawal of KSH 360 000 was made from the same account. *Korogocho Mirror* has also learnt that Mr. William Agara gave KSH 60 000 to the Kasarani MP for his personal use from the same amount. KSH 156 000 had also been previously withdrawn and given to the MP on request with a condition that it will be refunded. Up to now the said amount has never been refunded.

The said money was being managed by the Mathare road project committee through Shelter Community Project (Mathare) whose signatories are Messrs. William Agara, Vitalis Otullo and Phillip Odero Ochacha.

On July 18<sup>th</sup> 2007, the chairman of Shelter Community Project coerced Mr. Phillip Odero into resigning from being one of the bank account signatories. Mr. Phillip Odero duly tendered his resignation letter to the Manager of the Co-operative bank at Canon House on July 23<sup>rd</sup> 2007. However, on a twist of events, Mr. Phillip Odero wrote another letter to the same bank manager asking him to stop Mr. William Agara and Vitalis Otullo from withdrawing money from the account claiming that the two has taken advantage by mismanaging undisclosed amount of money. The case has already been filed at the Muthaiga police station.

“When a project has been allocated some money from the CDF, the money is normally taken to the project

committee bank account. Hon. William Omondi proxies are usually mandatory signatories,” alleges Mr. Silas Amanga, a former CDF committee member.

“How else do you expect us to monitor the funds?” retorted the MP when contacted by *Korogocho Mirror* over the issue.

This is against the backdrop of the CDF cheque that was coincidentally handed over from the Kasarani MP through a proxy to the Sports Minister, Hon. Maina Kamanda at a church funds drive worth KSH 10 000. Upon scrutinizing the cheque, the Sports Minister said that he would hand over the cheque to the Kenya Anti-Corruption Commission (KACA).

The aforementioned relatives have been playing the important role of scrutinizing and recommending project proposals to be forwarded to the Minister for eventual inclusion in the printed estimates of the following financial year.

“There is no single time that we have ever discussed any project allocation. The MP always came up with a list of projects to be funded by the kitty. It’s like few individuals made the key CDF decisions over their dinner table. I had to resign because I didn’t want to be somebody else rubber stamp,” alleges Mr. Silas Singoro Amanga. “His son was the supervisor when we were gravelling Korogocho/Ngomongo road,” said he.

MPs have the mandate of deciding whom to incorporate into the management of the CDF or not. The CDF Act 2003 stipulates that the CDF committee members shall be in the office for a period of two years and they are eligible for re-election for equivalent periods of time save for the ex-officio members.

“I wonder whether the National Management Committee who has among other roles the responsibility to ensure prudent management of the fund, is aware of what is happening in Kasarani,” wonders Pastor Samson Kinuthia.

The CDF act 2003 provides for the community participation right from the location level. “There is no time that the Korogocho residents have been mobilized and organized for the purposes of mapping out their needs and priorities that were to be funded by the CDF,” says Mr. Charles Waweru, a community development worker and resident of Korogocho.

For the past four financial years, starting from 2003-2007, the Kasarani CDF kitty has received a total of KSH 101 479 045.

# Hussein confirms race for Kasarani

**M**R Hussein Rashid Mohammed, 30, the Executive Director of Extreme Sports has finally confirmed that he is in the race for the Kasarani parliamentary seat.

“Kasarani is a metropolitan constituency where over the years has been ravaged by absolute poverty that have led to poor health, high illiteracy levels and lack of employment opportunities,” explains Hussein. “Kasarani is marred with a lot of tribalism. I would like to change that perception given that I have been brought up in the slums of Kawangware and Kibera where I have co-existed with people from different ethnic groups,” says Mr Hussein.

He further expounds that his key strategic issues that he shall deal with during his tenure are health, education and employment.

“When people are healthy, they are able to generate income for their up keep. When people are educated, they are in a position of gaining skills that shall lead to individual empowerment and when employment opportunities are opened up, they shall adequately and gainfully exercise their skills,” he expounds.

In an exclusive interview organized by CUP Kenya, the publishers of *Korogocho Mirror* newspapers and aired live on Koch FM, beneficiaries of Mr Hussein’s development projects which has benefited over 3000 youths directly all over the slums in Nairobi jammed the telephone lines as they wanted to air their congratulatory messages to the man whom they considered to be their savior.

“Hussein is very youthful, was

brought up in some of the most pathetic slums in Nairobi and is in touch with the problems facing youth not only in Kasarani but the whole country,” says Dominic Wachira, a resident of Mwiki.

Some of the initiatives that are attributed to Mr. Hussein’s efforts are Lucky Summer computer college, Babadogo batik youth project, Youth entrepreneurship fund in Mathare, Kariobangi, Mwiki, Githurai and Korogocho that each targeted over 20 youth groups. He is also nationally applauded for initiating youth football programme since 2004 all over Nairobi where he has pumped millions of money in terms of paying staff salaries, purchasing gifts to the winning teams and giving monetary rewards right from the quarter finals to the final match winners. He has contributed towards the rehabilitation of Roysambu football ground and also assisted in the development of Roysambu Primary School.

“Hussein is the hope for the youth. We want a better future and that future lies in him,” alleges Janet Wairimu, a resident of Kariobangi. “Time has come for us to vote for one of our own. We have all seen his development records and there is no dispute about that. I believe that what we need to do is to vote him in for him to continue with his good work,” cites Dominic Mwangi aka Domingo, a resident of Korogocho.

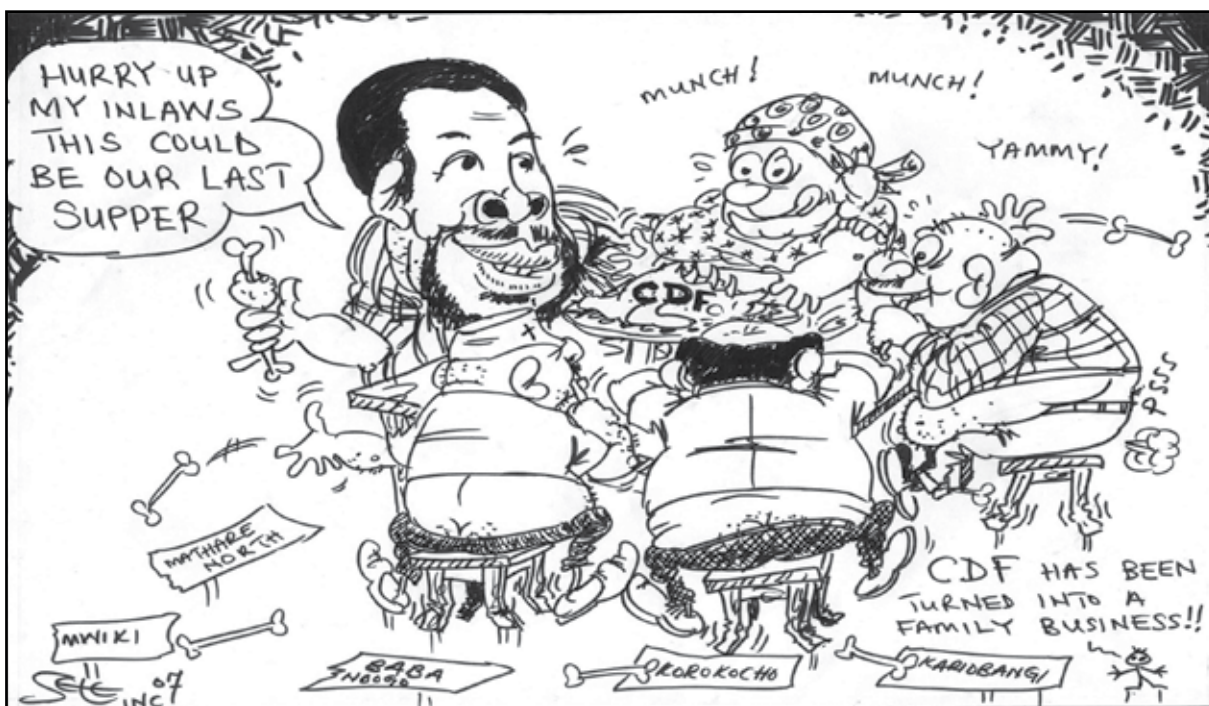

## Wezi weheshimiwa

THE recent reports of how the Kasarani MP, Hon. William Omondi attempted to present a cheque drawn from the CDF kitty to make a personal contribution towards a church fund drive is not only shameful but more so a confirmation of how MPs use public funds for personal gain. More shocking are the contradictions that followed when the area MP and the Fund managers attempted to explain the scandal. The two reminded me of a case where an accused pleaded guilty while his lawyer kept insisting that he was not guilty. If you were a judge in the case how would you arrive at your verdict/ No doubt, dealing with two liars is worse than dealing with just one.

Back to our constituency, the scandal brings to the fore the blatant corruption that mar management of CDF in Kasarani and similar constituencies. It highlights how dishonorable members of parliament-wezi waheshimiwa and their sycophants are mismanaging CDF in most parts of the country. Some have even placed their relatives and friends in the fund committees to protect their personal interests. This means that decisions affecting the constituents are arrived at in simple dinner gathering at the MPs house as reported elsewhere in this publication. Do you know what they offer as an excuse for doing that? That trust is so expensive to lease out to outsiders.

When devolved funds like CDF were established, the objective was to incorporate community participation in decision making for economic and social development. Ideally, such Programmes are noble as they provide an opportunity for citizens to actively engage in development at the local level and to have input in decisions concerning living conditions, access to resources and decision making structures. But unfortunately, they are not achieving much.

Though there are several key factors that stifle the effectiveness of the funds, the main obstacle include lack of cooperation from political leaders and the public fund managers. Apparently, politicians and like-minded public fund managers seem not to be interested in supporting people's participation

and information flow. Many people have difficulty accessing the institutions and processes that affect decisions.

Consequently, the processes have been marred with blatant corruption that is compounded with impunity and lack of accountability. Many MPs and their cohorts public fund managers misinterpret demands for accountability to mean mistrust. Some are even bold enough to brush off demands for accountability that they claim is ill driven. They don't seem to realize that accountability simply means regarding people as actors in governance and in particular decision making and mere implementers of decisions generated in the board rooms by a clique of individuals.

Indeed, peoples' participation and accountability must be taken seriously at all levels. People must remain in the guiding principles and the driver of the process. But in the light of the political realities, this will never be an easy task, much effort and strategy is required in organizing local groups to mobilize mass support and exercise a watchdog function to ensure that political resources are properly managed for the common good.

On the other hand, the Government, National Management Committees and the Kenya Anti Corruption Commission must sharpen their teeth to deal decisively with the rogue honorable and managers who misappropriate public funds. They must be held to account.

The case of Kasarani CDF calls for urgent need to reform CDF management by delinking it from the parliamentarians. In this view, there is need to devise effective community ownership and accountability mechanisms to ensure the impact of funds. It is vital to acknowledge that until we eliminate politicians from the management of devolved funds the much-needed development will remain a distant dream.

# Stem off the honourable thugs

THE rationale behind the establishment of the CDF cannot be contested at this point in time.

Largely, all the citizens of this nation agree to a large extend that the establishment of the fund may as well go down as one of the best avenues of development this nation ever tried.

In the short while the fund has existed, it has made a difference though little in the lives of many people living in the slums.

The political elite now agrees almost entirely that the government has wasted enormous resources in the last 40 years or so through the purely centralized system.

That far, that good but: the fund should actually be offering more than it is doing at the moment. This is a fund that has a large potential but its constricted and muzzled by politics and politicians for political mileage.

What the fund is lacking at the moment are the requisite structures to sustain it. This is what provides the existing loophole for misuse and embezzlement.

With the existing provisions as stipulated in the CDF Act 2003, many of us will not fare any better than the MPs we are currently complaining about if we are put in the same reigns of leadership.

The thing we should be doing is to put mechanisms in place to end the blame game. Structures that limit the powers of the MPs should be fixed around the Act to create room for professional conduct and prudent management of the fund through transferring mandate from the politicians to some other broad based participatory structure.

There are problems with the project identification modes, and the general participation of the citizens. For example, there are no guidelines given on even the basic qualifications of the constituency office employees.

What Kenyans are complaining about is the lack of separation of powers. What is stunning is that the parliament is making the law and the MPs are implementing it!

This is against the principle of separation of powers and undermines cardinal rules of good governance. This does not augur well for the building of a democratic state.

Most committees that run the fund, just like the MPs, lack the technical capacity to account for the resources and if some have, they are isolated and uncoordinated.

Moreover, the fund does not also provide for some expenditure like transport within the constituency or even allowances for officials who run the fund, creating a situation where either inertia or theft will overcome those appointed or selected to run the CDF.

There is also an element of duplication in many of the projects implemented in the same geographical location. There are situations in which the Local Authority Transfer Fund (LATF) and other line ministries implement similar projects, mostly on paper to facilitate theft of funds.

The MPs need to be engaged in rigorous vetting and offer explanations on hoe they used the fund before the end of their term. There is also need to establish a structured collaboration mechanism to aid in counter checking projects funding in the same geographical area to see what other development agents are doing in the same area. Most importantly, the citizenry need to be more vigilant to detect any looting from the funds by the *honorable* thugs!

# Who is Akon?

Aliane Thiam, known as Akon, born in Senegal, is an R&B singer who released his debut album "Trouble" in 2004, which included the singles "Locked Up" [Remix] (featuring Styles P), "Bananza" and "Ghetto". "Locked Up" reached the top 10 in the US, and the top 5 in the UK.

"Ghetto" also became a radio hit when it was remixed to include verses from legendary rappers Notorious B.I.G. (Christopher Wallace) and 2Pac (Tupac Shakur).

Recently, he has also released the single "Lonely" (sampled Bobby Vinton), which has reached top 10 on the US charts.

The mere act of surviving on a day to day basis is the foundation from which a true artist builds his craft.

Multi-talented newcomer AKON is no exception to this rule.

But rather than sensationalize his own drama,

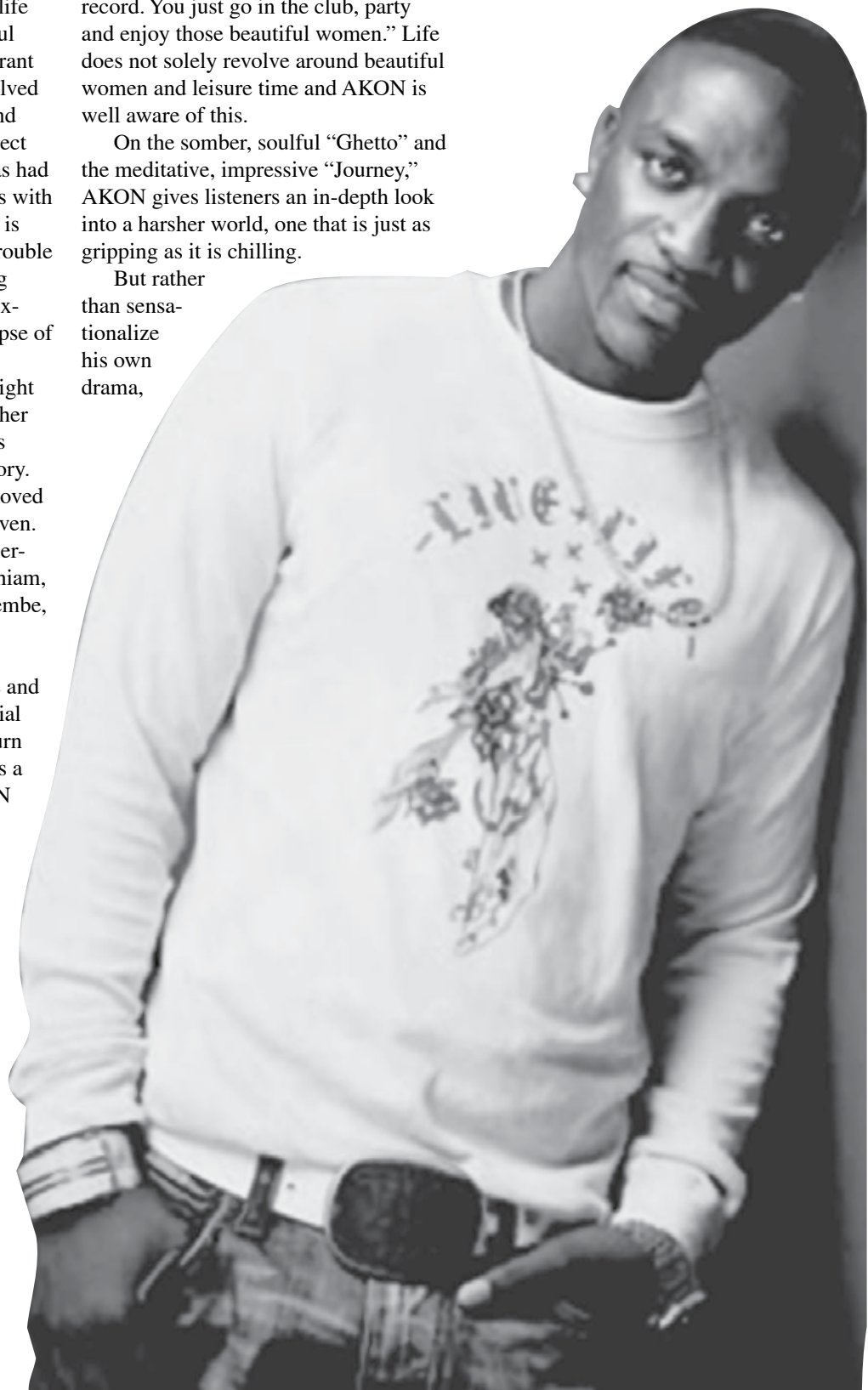
AKON transmits, to his audience, the feeling of being a part of his inner circle.

It is a saddening reality that despite the many visitors that tour slums or rather peoples settlements especially in Kenya the living standards in such areas still remain unchanged not by an inch. Indeed, every celebrity that comes to Kenya is taken to either, Kibera, Korogocho or Mathare or such like areas but all they leave behind are a litany of promises which in many cases never come to pass. Just recently the UN Secretary General Mr. Ban Ki-Moon added his name to the list of the renowned personalities that have toured the Kibera slums.

It is reported that he encouraged the residents of Kibera urging them to keep their faith and hope alive. While this is remarkable, it would be vital to note that the residents of Kibera and such other slums have kept their faith for far too long, it is the Government, political leaders, some NGOs, developmental agencies the International community and the visitors who tour the area as a zoo that renege on their promises. It is true they need hope to reverse such trends but above all else they need genuine and committed partnership. They need concerted, sustained and determined action not just sympathy and mere words.

I agree entirely with the retired president of South Africa Mr. Nelson Mandela who once said that overcoming poverty is not a gesture of charity but an act of justice. # The pain of being raped

AN evening in 2002 when my Buddies and I were heading home we were car jacked and unfortunately

I was Sexually Assaulted being the only female in the quorum. I spent six hours with the perpetrators and went through the ordeal of violation Physically, Emotionally, Psychologically and Spiritually, hence taking me two and a half years to recover. I was taken in a thicket where the perpetrator asked me at gunpoint to take off my pants where I hesitated because I could not visualize or accept what was about to happen to me while his colleague guarded the entrance.

In my hesitation the perpetrator removed a bullet and handed it to me to have a feel of what would penetrate my body if I did not comply. In a state of shock and disbelief that for me there was no escape he undid my pants an event that I remember vividly for I was numb and in denial "Why me God". He told me to bend down still holding the gun to my head and the bullet still in my hand.....he penetrated me from the back.

To be honest with you reader my mind and body switched off at that moment I tried crying, screaming, running, vomiting and any thing else you would imagine off but I couldn't, am trying to remember the events at that time but I can't (memory lapse). I found myself dressed and on the road with the perpetrators robbing people who were coming from work or a night out at around 6am, as I started coming back to reality and realized what had happened I felt violated, cheated and filthy.

The perpetrators gave me a hundred shilling note from the cash they had stolen from my buddies, I and the other passerby for they didn't have cash in small denominations, all this time they weren't in a hurry to finish what they had set to do. One of them was given the responsibility of taking me to the bus stop where I took a matatu to Buru buru police station not knowing where I will begin or end, fortunately when I alighted at the junction of Buru buru I saw a police car thinking that they will come to my aid and empathize with me for what I went through. Rude shock when I told them of what had transpired the best they would say is "umelolewa ama una boyfriend usiwambie chochote watakuwacha" (are you married or have a boyfriend don't tell them anything because if you do they will disown you).

When we went to record the statement they recognized the robbery as it were "robbery with violence" and Rape to them was not a crime, even the initiative of taking me to hospital was not significant to them. As they went to pick their boss from his residence

they dropped me at Donholm where I took another matatu home, in all this I was a human being with no feelings (numbness took over my whole body).

After I alighted the matatu the first person I saw was my sister heading to work who was shocked to see me in the situation I was in (dripping wet, confused, tired, sleepy, frustrated). All I asked her to do is call her work place and say she will be late, we went back home took a shower, changed cloths (not recommended to preserve evidence) but I did it anyway and we were on the way to Hospital. In doing all this I did not have any money on me borrowed what my sister had and in all this I was not thinking of calling my parents and telling them what had happened because as a family we lacked communication (a dysfunctional family).

On reaching St. Mary's Hospital (all this time am using public means you can imagine the terror) I told them what had happened and they collected samples from my vaginal walls to test for any sexual

transmitted Disease. I haven't gotten any first aid counseling at this point and to add salt to the injury the perpetrator(s) had syphilis or gonorrhea that I got to know when I requested for help from my aunt who worked then for AAR on reading the result slip. I could not stand the fact that I might be risking my life by waiting for treatment at St. Mary's Hospital where they were over whelmed by patients because they have reasonable rates for treatment which at the time seemed appropriate for me because I didn't have the cash to go to a private hospital for treatment.

When my aunt saw the result slip she was shocked and asked where I had gotten it from which I could not explain so I left the explanations to my sister who had accompanied me and sort refuge to a couch where I feel a sleep as I waited for my aunt to arrange for me to see a doctor. At last I saw a doctor and who prescribed medicine (ARV's, morning after, others for the STD, a HIV and UDRL test) worth over Kshs30,000.00 and insisted that I should get them and start using them before 48hours were over. With the cash my sister had and borrowed from my Aunt I managed to get all the prescribed medicine for a month, in all this I withdrew from every one like for two months, locked myself in the house where I was living alone.

After sometime I was forced to get out of the house to earn a living because soon I would be thrown out by the landlord, the first few weeks in town I was horrified because I would see the faces of the perpetrators every where I went but I pressed on. Unable to cope with the situation I went to see a counselor two sessions but one the third of I chickened out and saw no sense in continuing with the therapy because I blamed myself because

of what had happened to me and the only way I saw out was consumption of alcohol for two and half years.

If I was to turn the clock back I shouldn't have given up the therapy sessions for what ever reasons and consumption of alcohol, drugs or turning to prostitution does not help in the healing process at all wouldn't advocate for it. At some point because of the violation of my body I didn't know if I had lost my sexuality so I would prey on men I knew and have sex "mechanical" with them but played it safe by using a condom because my HIV status was Negative and need it to stay that way. In my drinking spree I met a gentleman whom I got to know and fell in love and still is to my surprise I never saw him as one of the perpetrators reality checked in that I have not been myself for sometime and needed to deal with my anger and resentment towards men for not all are ruthless.

I took a step in cleaning up my act and registered myself at Amani Counseling Center for a certificate course in Psychotherapy where I had to deal with all my issues and learn on how to help others going through the same violation off Sexual Assault. As at now am pursuing A Higher Diploma in psychotherapy and glad to let you know that being a victim of Sexual Assault and having gone through the above experiences I have established Wangu Kanja Foundation (K) to be a home for victims of Sexual Assault both female and Male (young and old).

My wishes are to have a justice system that will support victims of

This problem may be made worse by what he believes to be correct even when he has no evidence no matter how hard you try to prove yourself.  
It is an advantage for you that you will do your exams this year and will leave him with his unhelpful thoughts. Since your conscience is clear, it is advisable not to get into a confrontation with him or try to emphasize your popularity. Instead, get busy with examination preparation and do less socializing since in any case the forthcoming exams will demand more time from you. I need your help.

Dear Nerea,  
I appreciate your fear that this man may stop you from going to college. I also identify with your fear that he may divorce you too, considering that he has been divorced before. I imagine the fact that you love him yet cannot trust him confuses you even more.  
While at this point in your life I would encourage you to think about your school work, I also realize this is something disturbing you and it needs to be sorted out. To start with, I believe there must be reasons that made your friend divorce when he did. It is not clear whether in the time you have known him he has explained this to you. Knowing this would be a step towards reducing your anxiety about this friendship. There is also need for you to discuss your college plans with him so that you see whether he is willing to wait for you to finish college.  
Once the circumstances are clear to you, then you will be in a better position to make a decision. You must realize that this calls for new responsibility and you need to evaluate your ability to cope with it. Do not lose track of the fact that he may be interested in you because he needs someone to look after the children and not necessarily because he loves you. Political pundits have predicted that the battle for the Kasarani constituency parliamentary seat shall be fought on the CDF management agenda. For the past four financial years several questions remain answered, as our attempts to interview the MP were futile.

Why is it that the Korogocho electricity supply in the financial year 2004/2005 project status report indicated that the project had already started and was on going yet nothing was happening on the ground?

Why is it that Kariobangi North Development Youth Center is still at the foundation level yet a total of KSH 12 800 000 has been allocated to the project?

According to CDF regulations, unstarted CDF projects’ allocations have to be returned to the Ministry. Why is it that most of the development projects have not taken off?

According to CDF regulations, unstarted CDF projects’ allocations have to be returned to the Ministry. Why is it that most of the development projects have not taken off?

Why is the constituency office housed at Church house where the MP has been conducting private business through the name Akiba Housing Development Co. Ltd prior to his election to parliament in 2002 up to now? Why shouldn’t we think that it’s a matter of conflict of interest? Isn’t it improper use of public resources?

The emergency reserve is a portion of the fund, equivalent to 5% of the

total CDF allocation that is meant to remain unallocated and is available for emergencies that may occur at the constituency. For the past four years, Kasarani constituency has been allocated over KSH 9 million yet only KSH 1 200 000 has been used for handling emergency issues. What was the amount used for?

Why did the MP nominate his wife and relatives to the CDF committee? Why make a personal contribution to a funds drive with money to be with drawn from the CDF kitty?

“There is dire need for an independent evaluation under the supervision of KACA officials, of all the CDF projects in order for us to know the actual progress report of the said projects before the forthcoming general elections,” said Mr. Hesbon Otieno, a human rights activist. “It’s only then that we shall be contented,” he further adds.

Sexual Assault and a recovery center that they will call home as they recover and help them integrate back to the society fully recovered.

It’s a painful experience that too many people are going through and they have no place to turn too, Wangu Kanja Foundation (K) established in 2006,is in the midst of making great changes in its understanding and remedying of the injuries and injustices of Sexual Assault (rape/sodomy).

As a Victim of Sexual Assault you will encounter negative reactions from others you must not give up, it’s very

important for you to remember that there are other people right in your own society who do understand? There are people close by who are willing to fight for your rights, and people who are willing to help you every step of the way. It’s because of God’s Grace that I was able to come through it and establish a Non- Political, Non Profit making and Charitable Organization with the aim of helping all Sexual Assault Victims country wide. Today, many Sexual Assault victims continue to encounter the challenges of victimization from their families, friends, acquaintances, and authorities.

Our society needs to be sensitized about Sexual Assault and the Implications it has on the victims holistically. We at Wangu Kanja Foundation (K) focus on providing support,

protection, and legal advice in the eventualities of Sexual Assault. A common problem for Sexual Assault victims is that it’s very difficult to ask for help because Sexual Assault has made them feel ashamed, weak, and wounded.

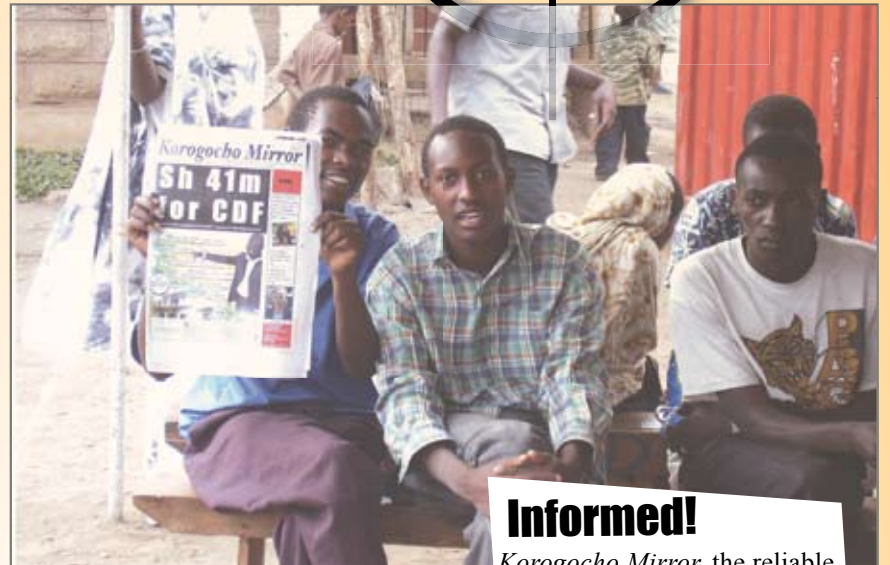

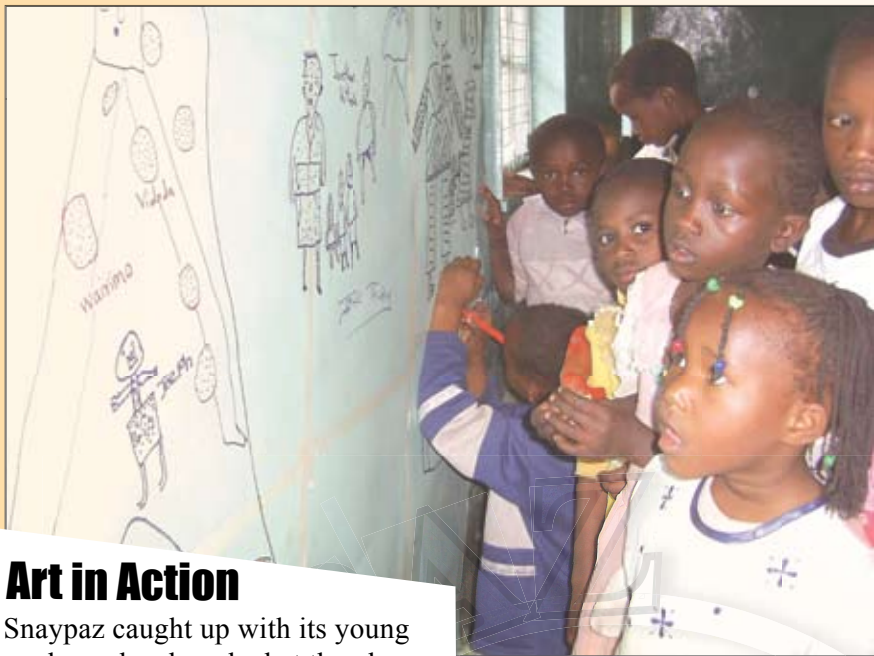
